## **DIRECT DEBIT TERMS AND CONDITIONS**

If you renew your membership by Direct Debit a notice of renewal will be sent to you 21 days prior to your renewal date. Your membership will be automatically renewed annually upon expiry unless you instruct British Showjumping otherwise and in writing at least 14 days prior to the date of expiry.

If you renew your membership and your horse/pony registration(s) a notice of renewal will be sent to you 21 days prior to your renewal date. Your membership and or horse/pony registration will be automatically renewed annually upon expiry unless you instruct British Showjumping otherwise and in writing at least 14 days prior to the date of expiry.

If British Showjumping does not receive written notification from the account holder requesting that a membership and or registration should not be renewed automatically at least 14 days prior to the date of expiry the registration will automatically be renewed and charged to your account. These transactions are non-refundable.

Any member not having paid their registration(s) 30 days from the renewal date shall cease to be entitled to any rights and privileges of membership until the outstanding registration(s) is paid in full. Your personal liability insurance becomes invalid if your membership and or registration remains unpaid after 30 days and cannot be backdated.

A variable amount direct debit mandate maybe cancelled at any time by informing your bank and British Showjumping in writing.
