FEI HORSE REGISTRATION APPLICATION



1. As from 1st January 2006, all horses wishing to compete at International Shows (under FEI Rules), whether in Britain or overseas, **MUST** be registered with the FEI, via the British Showjumping
2. It is imperative that you read and familiarise yourself with the BEF Rule Book which contains all up to date anti doping regulations. This can be downloaded from the BEF website (www.bef.co.uk). Alternatively it can be e-mailed or sent to you by post on request from the British Showjumping International Office.
3. Ensure the appropriate payment is enclosed with your application. Cheques made payable to the British Showjumping
4. The cost of registration for 2010 is:
 - £15.00 PER HORSE
5. Please note that horse registration expires on 31st December of that year and is therefore renewable for each calendar year.
6. **ALL REGISTRATIONS MUST BE COMPLETED PRIOR TO ENTRY.** FEI Registration numbers will be produced on the FEI web site every Wednesday morning. **It is your responsibility to ensure that your horses are registered prior to entry at an FEI Competition.** PLEASE REMEMBER THAT IF YOUR HORSE(S) ARE NOT FEI REGISTERED YOU WILL NOT RECEIVE POINTS TOWARDS THE FEI WORLD RANKING LIST. Winnings gained on un-registered horses will not be counted, and WILL NOT BE BACK DATED. Unregistered horses will be stopped from competing in International competitions.
7. All horses resident in Britain and wishing to compete at CSI**/**/****/***** , -O, - W, - V, -Y, -J, -P, CH are still required to hold a valid FEI Passport. All horses based and competing abroad at any level of FEI Competition are also required to hold a valid FEI Passport.
