Lead Official

In the coming months Show Organisers will be required to appoint a Lead Official to each arena at affiliated events. The Show Organiser/Organising committee shall nominate one Level 2 or above Judge to act as Lead Official for each arena for the duration of the show day. The Show Organiser/Organising committee will be required to allow sufficient time and resources for the lead official to carry out the relevant duties and checks.

The duties of the of the Lead Official are to take overall responsibility for the appointed arena, assist and advise the Show Organiser/ Organising committee on all aspects of Showjumping, ensure that all aspects of the event are run in accordance with the Rules of the Association, to act as adjudicator on formal objections, in accordance to rule 198.5 (in the absence of an appointed Chairman of Judges) and to submit a Lead Officials Show report to British Showjumping in a timely fashion.

The Lead Official shall not have any direct personal, professional or financial relationship, in or with the organisation of the show, including, but not limited to, relationships of family members that could influence or be perceived to influence objectivity when representing or conducting business or other dealings for, or on behalf of, British Showjumping.

We will look to intergrate the Show Report into Members Online within the official's drop down and the Judges App. Lead Officials will have 7 days to complete the form online and all Lead Officials show reports will need to be submitted electronically via the Members Online account or through the Judges App (access through the Judges App will be added at a later date).

The new/clarification of the position is intended to create clear responsibility and accountability within the Officials team, gives a clear point of contact for Head Office and strengthens the position of the Officials within the overall show organisation.

Shows already scheduled will not need to be re scheduled or re appointed, however as soon as the systems are in place in Head Office all new schedules will need to have Lead Officials appointed. We will keep you advised as to when these systems will be in place and when shows will need to start appointing Lead Officials.

Official Booking / Appointments

As part of the changes with Lead Officials we have made changes to how Officials are booked via the scheduling online system. As you may have noticed, when a Show Organiser books an official, the automatic email that is generated has slightly changed. There is now a section within that email where you can accept or reject the request to officiate at the show. When the Lead Official appointments go live, it will also be a requirement for Officials to accept or reject the booking via the email or through Members Online in the normal way. Along with these changes, Officials status will also be checked and verified by the system to ensure the correct level of Official have been appointed dependent on the classes scheduled.

Judges App Updates

The Judges App has been going from strength to strength over the past few months and the number of shows being uploaded has been holding steady between 57% and 67% of shows week on week fully uploaded which is way beyond where we thought the App would be after such a short time.

All we can say is thank you to everyone who has been uploading and providing such useful and positive feedback which means we are improving the App all the time.

A number of updates were released earlier this month and they are detailed below:

Changes:

- Schools Team results will now appear on the judging page as attached.
- Buttons are next to Competition Start and End Times to allow fast entry. These buttons will only be enabled on the day of the competition and round to the closest 5 minutes.
- Time competed now uses the time at the first fence, again this only works on the day of competition.
- PDF print output includes results instead of owner name, as attached.
- Rider age will now be displayed as Under 18 or 18+. Full age is still shown for rule infringements. As attached.
- Cancelled classes can now be un-cancelled.
- All times are correct with the rulebook, including reverse calculations there was a discrepancy with some of the 300m/m times.
- Number of prizes to be allocated is now corrected and will also display at the top of the judging screen, as attached.

Postponed Changes:

- Displaying number of DCs / Competitors
- Display of results on a second screen for public display this will be done when there is a gap in development commitments.

User statuses

As you will be aware as of Summer 2018 all second rounds and direct qualifier results will have to be uploaded via the App. We have therefore created a list of judges who can use the App to enable the show organisers to book their judges accordingly.

It was felt that the App users needed to be categorised by a set competencies and we have detailed the criteria on the <u>website</u>. There will be 3 levels of App user as detailed below.

- Judges App Trainee
- Judges App User
- Judges App Advanced User

Only Judges App Users & Judges App Advanced Users will be able to be appointed to a Second Round or Direct Qualifier to use the App. Current levels have been set according to the criteria within the document and these Levels and competencies will be reviewed quarterly.

Organisers will be able to search for Judges that have been accredited to use the app on the British Showjumping Website.
