Newcomers/Foxhunter A7

Newcomers and Foxhunters Table A7: As of 1 October 2016 Newcomers and Foxhunter competitions will be permitted to be Scheduled and run as either A7 / Two Phase or Single Phase at the Show Organisers Discretion. It has been agreed by National Sport to let this run for a trial period of 12 months but encourage Show Organisers to run a balanced number of Table A7. Implementation will commence from 1st October 2016 and will be reviewed after 12 months.

Changing of Class tables

With the above in mind can I remind all Judges that the changing of tables from that <u>scheduled</u> should still only be done in extreme circumstances and within the current rules. Permission to change class tables on the day will still need to be sought from head office in the normal manner or as per the rules in the handbook.

Judging sheets

Also could I ask all judges to ensure that the judging sheets are completed in full. Judging sheets are not always completed correctly which can make grading difficult, for example times missing (this is worse on schools classes as we need all times for the system to place the correct order of the teams etc.), distances missing, course builders missing, entries on tickets recorded in the results etc., could we all please ensure that each section is fully completed before sending results into us.

Can the judges returning the results send them back after each show rather than waiting maybe another week or two as they are judging elsewhere, as this delays results going onto records.

Entries not always put down in the right section or sometimes no section mentioned on the judging sheets again could they make sure this is clearly on for every class, as well as start lists sent into us.

Please could I remind you that judges are to hold and retain the Pink copy of the judging sheets for a minimum of six months. This enables us to check with the appointed officials over any queries that may arise from the results.

Single phase / Two Phase

Can the time for both sections of single and two phase be recorded on the sheets please, this is good practice and should be recorded on the sheets by the judge for reference at the show or a later date.

Free Tickets

British Showjumping is still giving out free tickets to ride across the country. If you are in the box when these come in could we ask that judges write FREE TICKET on the Judging sheets, so that these can be easily identified by the Account department as some shows have been incorrectly charged for free tickets.

Combined Classes (Amateurs & Opens)

Please can I remind Judges that when a National Amateur First Round is scheduled with an Open section that two sets of prize money <u>must</u> be awarded.

Updates & Reminders

Boot Rule: Please remember that <u>No additional elements may be used in conjunction with the protection</u>. No bandages, vet wrap, tape, fetlock rings only the boot as described below. Please also be aware, Hind boots for classes under this rule that have an extra flap for protection (pictured below) should be allowed providing the flap is soft and is clearly intended for protection only.

British Showjumping Horse Boots/Leg Protection Ruling

The following ruling is applicable for the following British Showjumping Competitions:

- •Talent Seeker qualifiers
- •Talent Seeker Final
- •Senior Newcomers Second Rounds
- •Senior Newcomers Final
- •Senior Foxhunter Second Rounds
- •Senior Foxhunter Final
- •Plus all Age Classes

The total maximum weight of equipment allowed to be added to an animals leg; front or hind (single or multiple boots, fetlock rings etc), is 500g.

All hind leg protections must have a maximum interior length of 16cm and a minimum exterior width of 5cm.

The inside protection must be smooth and the fixations must be made of non-elastic Velcro type fasteners with no hooks or straps permitted.

The rounded rigid part of the protection must be placed around the inside of the fetlock. No additional elements may be used in conjunction with the protection.

FAILURE TO COMPLY WILL INCUR ELIMINATION

Note: Hind boots for classes under this rule that have an extra flap for protection should be allowed providing the flap is soft and is clearly intended for protection only.
