PRACTICAL INSTRUCTIONS FOR HEALTH AND **CUSTOMS FORMALITIES** 

(Morocco Royal Tour& Salon du Cheval)

1. Travelling

To facilitate the preparation of veterinary and administrative records for the transit, the Salon du Cheval

Association and Morocco Royal Tour, in collaboration with the concerned officials services, make available

to the horse owners a personalized support for the preparation of the formalities, the reception at ports and

airports in Morocco and routing to the stables as well as for the return (Travel back).

For this, the following company was mandated to assist any person wishing to entrust this task.

2. Official Forms needing to be sent

After confirming the participation in various events and competitions, and to facilitate the transit, it is

necessary to send to the coordination unit and / or the transit agent the copies of horse identification in

order to prepare the import permit.

Copies of other documents that are mentioned below, must also reach us for verification and preparation of

the control in Spain and Morocco.

Two records are needed:

1. A Health record including:

The horse passport or an accompanying document.

• The health certificate, the standards form is available on the website, signed by the official

veterinarian and not a private veterinarian (all countries).

Horses must be correctly vaccinated against influenza and Rhino pneumonia

Laboratory analysis certificates for:

Infectious anaemia (Coggins test): within 30 days before starting.

- **Dourine and Glanders**: within 15 days of export (except for horses who have not left the EU and Switzerland during the last six months prior to export; except for travelling

to Canada and the USA)

3. Dogs:

If you wish to bring with you pets (dogs), they must satisfy the following conditions:

• **Identified** by an electronic chip (transponder) implanted under the skin;

• A valid vaccination against rabies (primary immunization and booster);

Undergone a serum antibody titration of rabies antibodies (laboratory examination performed

on a blood sample that ensures the effectiveness of the rabies vaccination of the animal) that

was carried out in a laboratory approved by the European Union at least 30 days after the

vaccination of the animal and at least three months before its importation. The serum titration

result must be greater than or equal to 0.5 IU / ml.

4. ATA Carnet:

The ATA Carnet is an international customs document that permits the tax-free and duty-free temporary

export and import of goods for up to one year. The Carnet eliminates the need to purchase temporary import

bonds.

The ATA Carnet indicating the horses and the equipment is provided by the local chamber of

commerce.

**5.** Forwarding Agents (Transitaire)

The Forwarding (Transitaire) costs and the crossing fees concerning the horses will be paid by the show.

Two national transit companies are organised by the Show both on the Spanish and the Moroccan side.
