

Registration of Premises/Establishments that Export Equines to the EU or Northern Ireland

Guidance

If you wish to export horses or other equines such as donkeys, mules or zebras to the EU or wish to move them to Northern Ireland you need to comply with the conditions set out in Commission Delegated Regulation (EU) 2020/692 supplementing Regulation (EU) 2016/429 of the European Parliament and of the Council.

Although the EU Animal Health Regulation is not directly applicable in GB, this legislation sets out the conditions for entry into the EU (and Northern Ireland), and the movement and handling after entry of consignments of certain animals, germinal products and products of animal origin. Article 8 sets out the General requirements as regards the establishment of origin of the animals, including equines.

In addition to the specific requirements laid down in Parts II to V of this legislation, consignments of equines shall only be permitted to enter the EU if the establishment of origin of the kept animals complies with the following requirements:

- it must be registered by the Competent Authority of the Third Country or territory of origin and assigned a unique registration number
- it must have a system in place to maintain and to keep, for a minimum period of 3 years, up-to-date records containing at least the following information:
 - the species, categories, number and where relevant, identification of animals on the establishment
 - movements of animals into and out of the establishment
 - mortality in the establishment
- it must receive regular animal health visits from a veterinarian for the purpose of the detection of, and information on, signs indicative of the occurrence of diseases, including those listed diseases referred to in Annex I relevant for the particular species and category of animal, germinal product or product of animal origin and emerging diseases. Such animal health visits shall take place at frequencies that are proportionate to the risks posed by the establishment concerned.

Equine keepers in **England** and **Scotland** must complete this form if you own or manage premises (referred to as establishments in EU law) from where equines are exported, whether these premises are private stables/yard used only by you, or sites such as livery yards, equestrian event centres, showgrounds, racecourses etc.

If the premises is already registered and you know the CPH number, there is no need to re-register.

Once registered, APHA will allocate you a registration number (which may also be referred to as a County Parish Holding (CPH) number). This number should be used by anyone, including yourself, seeking to export equines from the premises.

Equine keepers in Wales are required to register for a CPH through Manage My CPH on RPW Online (www.gov.wales/rural-payments-wales-rpw-online). If you are not an existing RPW Online customer you can register by clicking on the Register link on the same page or call the customer contact centre on 0300 062 5004.

Registration is **voluntary** but unless the establishment has a registered CPH with APHA, or RPW for Welsh keepers, it will not be possible for an Official Veterinarian (OV) to certify a horse or other equine for export from GB to the EU or NI.
