

### NOTES OF THE NATIONAL SPORT COMMITTEE MEETING – 3rd February 2020

#### • Rule 77.3.6 Hors Concours

The combination (horse/pony and rider) that has jumped HC can jump competitively in subsequent classes in the same ring on the same day. The horse/pony cannot be competitive with a different rider in the same ring on the same day. Effective: 1<sup>st</sup> April

#### • Rule 101.9 Spurs

4. Rowelled spurs if worn, must have smooth rowels, with a diameter of no less than 1cm and no greater than 2cm, with a minimum width of 1.8mm. The rowels must sit in the Vertical plane; horizontal rowels are not allowed.

Effective immediately.

# Rule 15 British Showjumping Horse Boot/Leg Protection Ruling

All Amateur Classes, Just For School, Academy and Club competitions. 7. Fetlock rings may be used in addition or independently for protective purposes providing they are properly adjusted and providing the total weight of equipment on the horse's leg does not exceed 500 grams. Effective immediately.

#### • Rule 231 Order of Starting

6. All horses ridden by a single rider must be ridden in the sequence that appears on the jumping order in all rounds of a competition unless class specifications call for a new order for a second round and/or jump-off. If a rider with multiple horses competes out of the drawn sequence of their horses in any class with a drawn and posted order, the remaining out of sequence horses will be eliminated, unless the out of sequence rides are approved in advance by the judge.

Effective 1<sup>st</sup> April.

#### • Rule 279 Six Bars

1. The course for this competition comprises six vertical obstacles placed in a straight line with two non-jumping strides between each obstacle. In indoor arenas the first two obstacles may be placed on one straight line and the last four obstacles on a different straight line. The top element and fill of each obstacle must be poles only.

Effective immediately.

- International Rules
  - Members must ensure that all accounts, bills and outstanding debts in respect of entries and/or services at International events are paid in full and by the due dates stipulated.
  - Behaviours and personal standards that fall outside of those expected and explained above will be taken seriously and may result in disciplinary action being taken with the individual/s involved.
  - A Member shall also be in breach of this Rule in the event that any person who assists, represents or acts on behalf of or in the employment of such Member during the course of a show affiliated to British Showjumping, to the FEI or to any foreign national federation, conducts himself/ herself in such a manner that were he/she a Member of British Showjumping he would himself/herself be in breach of any of the provisions of "Code of conduct for Members Competing Overseas"

Effective immediately.

### • Rule 93 Indebtedness to British Showjumping

Any Member who fails to pay an outstanding debt or fine imposed by the Disciplinary Panel, the FEI or the Chief Executive by the date stipulated or who fails to pay for goods or services supplied by British Showjumping, including, but not limited to, the processing of memberships, registrations, members international debt, etc. Effective immediately.

#### • Prize money National Amateur Qualifiers

#### • National B & C final

Two double clears in any of the following classes to also count as qualification for National B & C final;

o Winter Grade C – qualifies for Grade C final only
o Winter Grade B & C – qualifies for Grade B Final only
o Blue Chip B & C – qualifies for Grade B & C Finals respectively

# • Wildcard/ Invitational places for Pony Finals

All pony finals where wildcards/invitations are available, to be eligible for these places combinations must have a performance result at height of the competition final as agreed by BS.
